I, Umesh Ved, Proprietor of M/s. - 1.2 The e-voting commenced from Sunday 30th June, 2019, 9:00 a.m. and ended on Monday 29th July, 2019 upto 5:00 p.m.
- 1.3 Particulars of all the postal ballot forms received from the Shareholders have been entered in a register separately maintained for the purpose in electronic mode.
- 1.4 I have downloaded the data of e-voting from the E- Voting website of Link Intime India Private Limited (LIIPL) (https://instavote.linkintime.co.in.) after the E-voting module was disabled) on 29th July, 2019 at 05.17 P.M.
