- 1.2 The e-voting commenced from Sunday, 16<sup>th</sup> February, 2025 09:00 a.m. and ended on Monday, 17<sup>th</sup> March, 2025 at 5:00 p.m.
- 1.3 I have downloaded the data of e-voting from the E-Voting website of National Securities Depository Limited (hereinafter referred to as "NSDL") (<https://www.evoting.nsdl.com>) after the E-voting module was disabled by the NSDL on 17<sup>th</sup> March, 2025.
- 1.4 The e-votes were unblocked 17<sup>th</sup> March, 2025 at 06:44 p.m. in presence of two witnesses namely Mr. Bhavik Dolatwal and Ms. Heena Hotwani, and they are not in the employment of the company.
